# STRATEGIC ADVISOR OHT & STUDENT PLACEMENT SUPERVISOR 12 MONTH CONTRACT

**Addiction Services Central Ontario** is seeking a highly motivated and energetic individual for the position of **Strategic Advisor OHT & Student Placement Supervisor**.

This position reports to the Director, Quality Assurance and works closely with members of the Leadership Team as the agency continues its active involvement in the development and implementation of Ontario Health Teams (OHTs) in York Region, North York and South Simcoe to support the mission and strategic directions of the agency, leveraging expertise in health system planning, policy and analysis. This position is part of the broader agency Leadership Team and is actively involved in representing and supporting the agency in Ontario Health Team meetings and other meetings, as determined by the Agency. This position will also be responsible for student placement activities within the organization including liaising with educational institutions to identify placement opportunities, interviewing students, and working with the Leadership Team to provide supervision to accepted students while completing placements.

## **About the Opportunity**

This is a 12 month Full-time Contract position, for 35 hours per week. Evening and weekend work may also be required.

This position will be based at our head office in Aurora, and the incumbent may be expected to travel to other ASCO offices or locations.

ASCO is required to follow all public health and provincial directives as well as of those of our Ontario Health Team partners as related to the pandemic and other health issues that may come forward, including but not limited to vaccination requirements.

# Duties and Responsibilities include but are not limited to:

#### General

- Actively support the Leadership Team in the development and implementation of OHTs that include ASCO.
- Ensure the agency leadership has a strong understanding of the opportunities, challenges and possible solutions associated with the Agency's participation in the development and implementation of Ontario Health Teams.
- Act as an agency representative on OHT working groups and other committees, as determined by the Agency.
- Provide project management leadership, development and implementation of other projects within the agency, as determined by the Agency.
- Identify opportunities for ASCO student placements, and work with educational institutions and
  the Leadership Team to support students in clinical and non-clinical student placements, including,
  but not limited to confirming required supervision for all students on placement in the Agency.

#### **Operations**

- Lead, organize and provide recommendations on the agency position as OHTs continue their development.
- Analyze data and reports to help determine agency position.
- Identify risks for the agency and recommend solutions.
- Lead, organize and prepare internal reports and presentations to assist in keeping the agency informed about OHT activities and to assist in making decisions, including identifying opportunities and risks.
- Support organizational planning as it relates to changes required to support OHT implementation.
- Support agency data collection as required by each OHT team in the planning and implementation phase.
- Actively work with the Leadership Team to identify need and capacity for student placements in the agency, and facilitate matching placement opportunities with supervisor(s) for student(s).
- Actively work with educational institutions to facilitate internal and external student placements.
- Actively work with multiple OHTs, leading and coordinating initiatives through committee involvement.
- Actively participate as a member of an OHT Backbone, as determined by the Agency.

## Relationship Management

- Engage with ASCO Clinical Leadership Team as needed to enable a sound clinical voice for the agency at OHT meetings.
- Build, maintain and strengthen OHT-related relationships with community agencies, acute care, primary care, other health care providers and other stakeholders.
- Provide recommendations on additional relationships to further the agency's leadership and involvement in OHTs.
- Collaborate on providing recommendations to support the overall strategic directions of the agency.
- Build and maintain relationships with educational institutions as it relates to clinical and nonclinical student placements.
- Other duties, as assigned

#### Qualifications:

- Master's Degree (or in progress) in Health Administration or related degree or an equivalent of 8-12 years' work experience in the health system
- Demonstrated understanding of the work of clinical treatment organizations
- Demonstrated relationship building and relationship management experience
- Demonstrated understanding of Ontario Health Teams and the role they play in the provincial health system
- A solid understanding of addictions and/or mental health issues faced by individuals in the community
- A strong understanding of public policy development
- Ability to analyze large amounts of data and identify trends
- Demonstrated ability to collaborate with a diverse team and different stakeholders
- Sound knowledge, awareness and understanding of anti-oppression and anti-racism (AOAR) practices
- Understanding of risk management principles
- Excellent inter-personal skills
- Excellent communication skills, both written and oral (English); the ability to communicate in French, a definite asset; the ability to communicate in another language, an asset
- Highly developed program and operational management skills
- Strong computer literacy, including full competency in Microsoft Office programs (Outlook, Word, Excel and PowerPoint)
- Strong attention to detail, excellent organizational skills, and sound problem-solving ability are required
